- In order to be valid, this form of proxy for the Domestic Shareholders' Class Meeting must be deposited by hand or by mail to the place of business of the Company not less than 24 hours before the time for holding the Domestic Shareholders' Class Meeting (i.e. before 9:00 a.m. on Tuesday, June 13, 2017) (or any adjournment thereof) for taking the poll. If the form of proxy is signed by a person under a power of attorney or other document(s) of authorization, a notarial copy of that power of attorney or other document(s) and authorization shall be deposited at the same time as mentioned above in the form of proxy.
- Where there are joint holders of any share, any one of such joint holders may vote, either in person or by proxy, in respect of such share as if he were solely entitled thereto, but if more than one of such joint holders are present at any meeting, the vote of the senior holder who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding. 8.
